ORDER

WHEREAS, the recognition was granted to the institution namely, **SNM Training College, Moothkunnam-683516, Ernakulam District, Kerala** vide SRC (NCTE) order No. F.KL/SE/N/20/SRO/NCTE/2002-2003/2316 dated 22/03/2000 for conducting B.Ed. course of one-year duration with an annual intake of 70 students from the academic session 2000-2001.

2. **AND WHEREAS**, the institution submitted written representation on **02.04.2014** requesting for increase of strength from 70 students to 150 students in its B.Ed. course. The matter was further considered by the SRC in its 263rd Meeting held on June 4th to 5th, 2014 and the Committee decided to issue Show Cause Notice. Accordingly, as per the decision of SRC a Show Cause Notice was issued to the institution on **31.07.2014**.

3. **AND WHEREAS**, the institution vide letter dated **14.08.2014** submitted reply to the Show Cause Notice. The matter was further considered by the SRC in its 273rd Meeting held on September 30th to 1st October, 2014 and the Committee decided to issue show cause notice.

4. **AND WHEREAS**, as per the decision of SRC a Show Cause Notice issued was issued to the institution on **12.11.2014**. The institution vide letter dated **24.03.2015** submitted reply to the show cause notice.

5. **AND WHEREAS**, after promulgation of NCTE Regulations, 2014, the institution consented to come under new Regulations vide notarized affidavit dated 29.01.2015.

6. **AND WHEREAS**, a Revised Provisional Recognition Order (RPRO) was issued to the institution on **26/05/2015** for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-2016 subject to submission of revalidated FDRs of the enhanced value in joint account with the SRC before 30 June, 2015 and fulfillment of the conditions mentioned at II & III herein before 31.10.2015.

7. **AND WHEREAS**, the SRC in its 369th meeting held on 28.01.2019 decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, as per the decision of SRC, a show cause notice was issued to the institution on **15/03/2019**. The institution vide letter dated **29.03.2019** submitted reply to the show cause notice.

8. **AND WHEREAS**, the matter was further considered by the SRC in its 386th Meeting held on July, 23-24, 2020 and the Committee decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

*On the perusal of the original file and the reply submitted by the institution on dt. 29.03.2019, the Committee decided that the continuation order be issued to the Institution **SNM Training College, Ernakulam District, Kerala** for B.Ed programme for 1 basic unit of 50 students".*

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information, if it so desires.

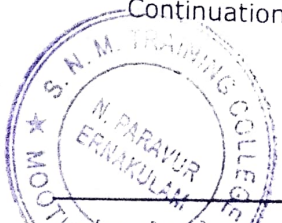
5. AND WHEREAS, accordingly, first Show Cause Notice issued on **03.10.2019** and the reply was received on **18.11.2019**.

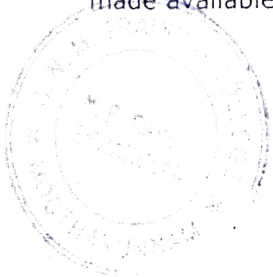
